A. Project Narrative

A.1 Existing Condition Description

Approximately 0.50 miles south of Ellsworth along the west side of Kansas Highway 14 (K-14), is a Good Samaritan Retirement Village and a housing subdivision called Canren Addition. There are currently nine houses in Canren Addition, with a tenth house located just to the north. K-14 is a two-lane asphalt roadway with no shoulders.

Approximately 0.10 miles south of the Smoky Hill River bridge is the Ellsworth County Fairgrounds, a rodeo arena, two baseball diamonds, and a large grassy area which is used for many activities such as: the annual 4th of July celebration, youth soccer and flag football practice, 4-H activities, traveling carnivals, and many others. This entire area is owned by the local governments. Directly southwest of the bridge are two more baseball fields and another large grassy area which is also utilized for many local events. This area is owned by the City.

Less than 0.10 miles north of the bridge is a sweet treat dispensary called the Sugar Shack as well as the Hodgden House Museum, both local attractions for old and young alike and the center of the annual Cowtown Days Celebration. A KAN-cycle bike sharing station was constructed by the museum in 2019. A few hundred feet further north is the downtown business district of Ellsworth consisting of retail shops, restaurants, professional services, and the Ellsworth Elementary School.

A.2 Project Needs

There is a proposed Workforce Housing Development project to construct 12 new homes in Canren Addition beginning in 2020. The estimated cost of the project is \$2.5 million. People currently walk and bicycle to Ellsworth from this area by utilizing the K-14 pavement or ditches. With minimal shoulders along the highway, pedestrian and bicycle travel on the roadway is an undesirable interaction with high speed automobile traffic. The posted speed limit is 50 mph from Kansas Highway 156 until the city limits. Walking in the ditch separates pedestrians from motorized vehicles but has its own perils of stepping in holes, stepping on refuse, or tripping in the tall grass. The proposed new homes are anticipated to attract families with young children. The roads within Canren Addition consist of gravel surfacing, also less than desirable for pedestrian traffic. Having an established multi-use pathway system in place from Canren Addition to Ellsworth would spark increased interest for young families to move into a new house knowing that safety features and amenities are in place. This pathway would connect the residents south of town with the Fairgrounds, public recreation facilities, the museum, and the downtown business district. It would be the city's priority to work collaboratively with the housing developer and Good Samaritan officials in developing a comprehensive multi-use pathway plan for connecting these neighborhoods with existing sidewalks that cross over the K-14/Smoky Hill River bridge.



A.3 Project Scope

The proposed neighborhood multi-use pathway project will provide for a safe and reliable route for adults and children to utilize instead of K-14 to connect them to the Good Samaritan Retirement Village and the Canren Addition Workforce Housing Development. The project scope is to construct an 8-foot-wide concrete path from the paved parking lot of Good Samaritan, north to the Smoky Hill River bridge. A pedestrian span bridge is proposed to cross the creek which runs along the south side of the fairgrounds. The bridge will not only provide a safe and efficient way to cross the creek but will also be an item of interest for users of the path.

The pathway will initially traverse along the western edge of the KDOT right of way of K-14. Just south of the creek, the pathway will diagonal northwest for a short distance to where the creek crossing is narrowed, thus allowing for a shorter bridge. The bridge will be located in the trees along the creek. The path will then continue north along the west side of the old armory building, following the east side of the gravel road to Ave K. After crossing Ave K to the north, the pathway will follow the alignment of an existing sidewalk east to Cleveland Ave. From there it will traverse northeast to an existing sidewalk coming from the Smoky Hill River bridge.

A.4 Project Benefits

The proposed pathway would provide a smooth ADA compliant concrete surface, away from K-14 traffic, for people to walk or bicycle between Ellsworth and the housing to the south of town. It further provides connectivity between the housing south of town, the fairgrounds, the museum, and the downtown business district. The separation of pedestrians and bicyclists from vehicular traffic on K-14 will be a safety improvement, while at the same time providing a scenic pathway for recreation and exercise for healthy living.

People seeking to utilize the pathway for the purpose of recreation and/or exercise could park at the fairgrounds and have a nearly one-mile round trip. Those seeking a longer adventure could park at the museum to get about a 1.75-mile round trip.

What a tremendous asset this pathway will be for attracting people and businesses to Ellsworth!

A.5 Project Readiness

The majority of the pathway is proposed to be constructed on publicly owned property. The city has talked with the KDOT Area Engineer and Maintenance Superintendent in Ellsworth about utilizing the western K-14 right of way from the Good Samaritan Village to the creek. A small tract of right of way may need to be acquired along the southern edge of the creek. The city owns property on the creek up to the K-14 right of way. The amount of right of way to be acquired is estimated to be 0.05 acres from one parcel. The landowner of this property has been contacted and has indicated that they would be open to idea of the pathway if it has minimal impact to their property.



There is a possibility that one or two power poles may need to be moved and perhaps a phone pedestal structure. The need for utility relocations will be determined during the preliminary design process. The pathway will be shifted where possible to avoid existing utilities.

The project has been on City Council meeting agendas twice in October 2019, where the project was discussed openly. No objections were raised during these meetings.



A RESOLUTION DECLARING THE ELIGIBILITY OF THE CITY OF ELLSWORTH TO SUBMIT AN APPLICATION TO THE KANSAS DEPARTMENT OF TRANSPORTATION FOR USE OF TRANSPORTATION ALTERNATIVES PROGRAM FUNDS SET FORTH BY MAP-21 FOR THE ELLSWORTH NEIGHBORHOOD MULTI-USE PATHWAY PROJECT IN ELLSWORTH, KANSAS AND AUTHORIZING THE CITY ADMINISTRATOR TO SIGN THIS APPLICATION.

Whereas, the City of Ellsworth, Kansas, has the legal authority to apply for, receive, and administer federal, state, and other monies through Home Rule Power under the Constitution of the State of Kansas and authorized by K.S.A. 12-1662, regarding the expenditure of federal-aid to public agencies; and

Whereas, the City of Ellsworth, Kansas, is submitting an application to the Kansas Department of Transportation for Transportation Alternatives (TA) Program funds in the amount of \$449,600 set forth by MAP-21 and as outlined in KDOT's Transportation Alternatives Program Guidance & Application Packet for 2021; and

Whereas, the City of Ellsworth, Kansas, is participating as an eligible Project Sponsor in the Kansas Department of Transportation's TA Program set forth by MAP-21; and

Whereas, Federal monies are available under a Transportation Alternatives Program set forth by MAP-21, administered by the State of Kansas, Department of Transportation, for the purpose of creating and promoting the planning and development of active transportation facilities and programs in Kansas; and

Whereas, the City of Ellsworth, Kansas, acknowledges availability of the required local match of no less than 20% of the cost of construction and construction engineering, as well as, the availability of funds to pay all upfront costs; and,

Whereas, after appropriate public input and due consideration, the Governing Body of the City of Ellsworth, Kansas, has recommended that an application be submitted to the State of Kansas for the Ellsworth Neighborhood Multi-Use Pathway project.


NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF ELLSWORTH, KANSAS:

- SECTION 4. That the City of Ellsworth, Kansas, hereby assures the Kansas Department of Transportation that the City of Ellsworth, Kansas, will have title or permanent easement to the project by the time of project letting, if necessary.
- SECTION 5. That the City Administrator of the City of Ellsworth, Kansas, is authorized to sign the application to the Kansas Department of Transportation for Transportation Alternatives Program funds set forth by MAP-21 on behalf of the citizens of the City of Ellsworth, Kansas. The City Administrator is also authorized to submit additional information as may be required and act as the official representative of the City of Ellsworth in this and subsequent related activities.

That the City of Ellsworth, Kansas, hereby assures the Kansas Department of Transportation that the City of Ellsworth, Kansas, is willing and able to, if the Ellsworth Neighborhood Multi-Use Pathway project is selected for funding, administer all activities involved with the Ellsworth Neighborhood Multi-Use Pathway project.

The facility complex four (4) ball fields that are used by the city and the school district.

The facility is used from March to August and serves over 500 people during this timeframe. Adding a multi-purpose pathway to our community, would allow children and adults to utilize this new asset for walking and riding their bicycles. Currently pedestrians and cyclist utilize K-14 shoulders to get to and from our complex, which creates an unsafe route for the community. The proposed pathway would eliminate those concerns

My name is Emil Halfhill and I'm the Chief of Police for the Ellsworth Kansas Police Department. I'm writing you this letter of support pertaining to a grant funding for a multi-purpose pathway project, which would connect the most southern part of Ellsworth to ball fields and Smoky Hill river bridge area.

Located south of town is the Recreation Center/Complex, which houses baseball, softball and t-ball along with other events throughout the year. These events include the Ellsworth County Fair, Ellsworth Cowtown Days, July 4th Celebrations and even a few car shows. Located just south, down K-14 Highway is an approx. 15 home subdivision along with a large multi structure nursing home, independent living quarters and an apartment complex. There is currently a project slated for 2020 to build several new single-family homes in the already established subdivision. These new homes will be income based and more likely then not, bring in new families including those with children.
